 - Pay Rent to Humanity
 - And and let Humanity use the received rent money to provide Spending Income
 - Offered to each and every man, woman and child on the face of this Earth

Defining Objective Land Claims

GENERAL BACKGROUND HYPOTHESIS

- The Earth does not belong to Humanity
 - At best, Humanity can only claim to be a trustee
- Individual Human Beings have "natural" access to land
 - They can go anywhere, anytime and for any purpose



Renterizer Defining Objective Land Claims

GENERAL BACKGROUND REALITY

- Humanity seems to have lost its job as trustee
 - May even have burnt its bridges
 - Set up the "United Nations" as substitute trustee
 - Along with other International bodies
 - Especially those without actual authority
- Individual Human Beings have lost "natural" access to land
 - Ever increasing number of "No Trespassing" signs
 - With evermore requirements to get a Pass(port)

GENERAL BACKGROUND SUGGESTION

- How can Humanity reclaim its role as trustee
 - Advocates the culture of Legitimate Sovereignty
 - A culture that does not initiate violence
 - With initiative: Offers to negotiate
 - Without initiative: Retaliates in kind
 - Introduces a country on the internet
 - Designed to become a Federation of Countries

GENERAL BACKGROUND SUGGESTION

- How do we deal with the loss of "natural" access to land
 - At least know enough to expect compensations
 - Compensations of worth to everybody
 - For instance: Money
 - And possibly others
 - Included in the Rental Agreement
 - Time to adjust
 - Sunset Clause
 - Grand Father Clause
 - Concern for the Environment

How do we deal with the loss of "natural" access to land

At least know enough to expect compensations

- Ties in well with the concept of Rent paid to Humanity
 - For territorial claims
 - Right to Territory becomes Right to the Claim itself
 - Again with the implied rental conditions



Renterizer Defining Objective Land Claims

GENERAL BACKGROUND PREPARATION

- Therefore, at first, we have one question
 - Do the claimants, of any land, pay rent to Humanity?
 - Whatever the "Original/Usual Criteria" used to "motivate" the claims
 - For example Japan and China both claim some islands
 - Known as the Senkaku isles in Japan and Diaoyu in China
 - They have their version of the "Original Criteria"
 - BUT DO THEY PAY RENT TO HUMANITY?
 - If not, then the claims can only be considered illegitimate
 - And the claimants should be sued for misrepresentation

INTRODUCING THE CONCEPT OF RENTERIZING

- Defined
 - Legitimate Claim related to land
- Refined
 - Rent paid to Humanity to justify claim related to land
- With a twist
 - Claims, related to land, always for sale

RENTERIZING: BASIC WHATIFFING

- What if we consider the entire Earth surface
- What if we account for the entire Earth population
- And... what if we simply pull a few figures out of a hat
- Can we show how we calculate the Rent Rate?
 - To get the Total Receivable from Land Claims
 - From that, deduce the Spending Income offered to each "interested" Human Beings

 - "Renterize" businesses claiming a Market Share
 - As a rough first step
 - But keep in mind that the Consumer always pays

 - Either directly or indirectly

 - We do not expect to reach the Holy Grail instantly
 - We start very small
 - At a Generic Level

- We certainly expect static
 - Especially from those with vested interest in the status quo
 - How much time do they need to adjust?

- That's why we Cultivate a Country on the Internet
 - Where we offers a Spending Income to everybody
 - No obligation other than signing up
 - And, in due time, keep introducing new features
 - Mostly adding clauses to the Land Claim Lease Agreement



Renterizer Defining Objective Land Claims

- Idealistic, to earmark the emotional fuel needed to get going and introduce the method to calculate Basic Rent Rate; the pie in the sky part
- Realistic Minimal, to get to the concrete fuel needed to keep going; the
 reasoning to kick start the system and get practice in using the system
- Realistic Generic, to increase the concrete fuel needed to keep going; the claim to practical elbow room and to get more practice in using the system; mostly the Basic Rent Rate
- Refined Specific, specifying the concrete fuel needed to keep going; what about Me and my Specific Land Claims; the "what is the catch part"
- Eventual Others, beyond the here and now; miscellaneous claims also subject to (Total) Rent Rate and to Renterizer Lease Conditions
